## Our charges

### Take off charge

Calculated on the basis of Maximum Take Off Weight (MTOW)

Each started ton	82 SEK
Minimum charge is	550 SEK

### Parking charge

Valid for all aircrafts parked on stands at Linköping City airport.

First three hours free of charge.

Daytime 06.00-22.00:	22 SEK/ton based on MTOW up to 24h.
Minimum charge	275 SEK
Nighttime 22.00-06.00:	1 650 SEK

### Environmental fee

Between 22.00-24.00	770 SEK
Between 24.00-05.00	1320 SEK
Between 05.00-06.00	770 SEK

### Extended and extra opening costs

**Requested and confirmed but not used extra opening will be fully charged.**

#### Extended opening

The charge is to keep ATS and rescue service open outside normal opening hours presented in AIP – Airport Information.

No charge within 15 minutes from normal closing. After 15 minutes the charge per commenced hour. Minimum charge is 1 hour.

31 <sup>st</sup> of October – 31 <sup>st</sup> of March	6 600 SEK per hour

### Extra opening

When extra opening is required not in direct connection with AIP published opening hours a minimum of 3 hours will be charged.

## Payment of charges and payment obligations

The aircraft owner, user and/or person acting as the representative of the owner of the aircraft are jointly and severally liable for the payment of the charges in this price list.

All rates are in SEK and are exclusive of any taxes or levies payable thereon. The total amount shall be rounded off to the next full SEK. Value added tax (VAT) shall be paid according to applicable law.

All charges described according to this price list are due to immediate payment to Linköping City Airport AB. Unless otherwise agreed in writing, the owner, pilot or representative of the aircraft shall report to the Airport Office immediately before take-off of immediately after landed at the airport.

Agreement can be made concerning periodic invoicing, provided the owner or user of the aircraft operates on a regular basis or has higher volume of traffic. Payment terms in 30 days net.

Upon request, the airline is obliged to make all necessary information available to Linköping City Airport for credit rating purposes. All information received will be treated confidentially.

In the event of failure to the charges due, the following provisions shall furthermore apply:

- Late payment will result in interest of overdue payment of 15,5% and an administrative cost of 100 SEK.
- In the event of failure to pay, Linköping City Airport may inform airline that it will not be allowed to operate from Linköping City Airport until all charges plus interest and service fees have been paid in full.
- In the event of failure to pay, Linköping City Airport is entitled by law to take legal action against the aircraft including but not limited to attachment of the aircraft itself, its fuel and engines irrespective of who may be from time to time the owner of such assets and Linköping City Airport will, without incurring any liability from the owner of the aircraft, the holder and user thereof and any person action as representative of the owner, the holder or user thereof be entitled to prevent the aircraft from departing from Linköping City Airport until all charges have been paid in full.

-Immediately after failure to pay, Linköping City Airport may demand a Banker's guarantee for the amount due and for expected charges for the following three months.

-After failure to pay, Linköping City Airport may change agreed payment terms concerning periodic invoicing and revert immediate payments for future take offs from the airport.
